The Club intends to make a limited number of Season Permits available to Non-Members during the 2018 Fishing Season. The Club in its absolute discretion may reject any application for a Non-Member Season Permit and this shall not be subject to any appeal process.

As in previous years, it is intended there will be no restriction on the number of Non-Member Season Permits for SixmileWater River available to persons aged 17 years and under.

Season Permits made available to Non-Members will be valid during the 2018 fishing season from **date of issue to 31 October**. For 2018 Season Permits for Potterswall will have be valid for one year (1st March 17 – 28 February 2019). For all permits fishing must not be commenced before **8.00 a.m. and must cease by 11.30 p.m.** each day.

All Season Permit holders must undertake to comply with the Rules and Regulations of the Club as may apply to Non-Members angling on Club waters whether published or issued before commencement of the fishing season or from time to time during the validity of their Season Permit.

Please note **fishing is ‘fly only’** and no other method is permitted.

All applications must be signed by the applicant and **accompanied with a cheque** for the full amount of the Season Permit Fee. Cheques should be made payable to “Antrim & District Angling Association” and must not be post-dated. All applications must be accompanied with a **prepaid stamped addressed envelope** and a **passport photograph**.

Please note **completed applications must arrive with the Treasurer by 26th February**.

It will be the responsibility of each applicant for a Non-Member Season Permit to ensure that their properly completed application is received by the Honorary Treasurer and the Club will accept no responsibility for lost applications.

Unsuccessful applicants will have their cheques returned in the prepaid envelope submitted with their application form.
